COOKIES POLICY

VER. 02/2022

A cookie is a small file of letters and numbers that is stored on client's browser or the hard drive of the computer if client agrees. Cookies contain information that is transferred to computer's hard drive.

The Company uses the following cookies:

- **Strictly necessary cookies.** These are cookies that are required for the operation of Company's website. They include, for example, cookies that enable client to log into secure areas of Company's website, use a shopping cart or make use of e-billing services.
- **Analytical or performance cookies.** These allow to recognise and count the number of visitors and to see how visitors move around Company's website when they are using it. This helps the Company to improve the way its website works, for example, by ensuring that users are finding what they are looking for easily.
- **Functionality cookies.** These are used to recognise client when he returns to Company's website. This enables to personalise content for particular client, greet client by name and remember his preferences (for example, client's choice of language or region).
- **Targeting cookies.** These cookies record client's visit to Company's website, the pages he has visited and the links he has followed. This information allows the Company to make its website and the advertising displayed on it more relevant to particular client's interests.

Information about the individual cookies the Company uses and the purposes for which the Company uses them in the table below:

Cookie Name	Purpose	Expiry period
_ga	Allows to distinguish between users for Google Analytics	2 years
_ym_isad	Used to determine if a visitor has ad blockers for Yandex metric	2 days
_ym_d	date of the first visit of the visitor to the site for Yandex metric	1 year
_ym_visorc_*	Allows Session Replay to function correctly for Yandex metric	30 minutes
_gid	Allows to distinguish between users for Google Analytics	1 day
_ym_uid	Allows to distinguish between users for Yandex metric	1 year
PHPSESSID	PHP session id	6 days
userid	Allows to distinguish between users	180 days

The Company shall not share the information collected by the cookies with any third parties.

The client can block cookies by activating the setting on his browser that allows him to refuse the setting of all or some cookies. However, if client uses his browser settings to block all cookies (including essential cookies) he may not be able to access all or parts of Company's website.
